Nonetheless, the PP's nudge of the CJ to get things moving will probably achieve this.

In which case I won't need to trouble the PP again.

I'll wait and see.

In the unlikely event that the JCC neglects to deal with my said long-outstanding complaint in the next three months, despite the PP's nudge, and presumably the CJ's in turn, I'll request an internal review of the PP's handling of the case within the 90 days allowed me by Rule 44(1) of the PP Rules.

For my records, and for use in my review request if the need arises, please furnish me, by the end of this week, with (i) the PP's letter to Maya CJ referring my complaint to the PP to her, (ii) the PP's covering email or other delivery voucher, and (iii) the CJ's acknowledgment if any.
